

Privacy Policy

Australia Remade knows that you care about how information about you is used and shared. This Privacy Policy explains what information of yours will be collected on this website, how the policy this information will be used, and how you can control the collection, correction and/or deletion of information. We will not use or share your information with anyone except as described in this Privacy Policy. This Privacy Policy does not apply to information we collect by other means (including offline) or from other sources.

Please note that while A24 and the Australia Remade project are a joint initiative of a number of organisations and individuals. Because it is an unincorporated alliance, A24 has a service agreement with the Centre for Australian Progress. Therefore the Centre for Australian Progress is the legal owner of this website, and is the legal entity obligated by this Australia Remade privacy policy.

Information we collect

User-Provided Information: You provide us information about yourself, such as your name, e-mail address or other contact information. If you correspond with us by email, we may retain the content of your email messages, your email address and our responses. You may also provide us information in user content you post on the Australia Remade website.

Third Party Services

Australia Remade uses the Squarespace platform to publish our content. When you visit us, Squarespace may send one or more cookies a small text file containing a string of alphanumeric characters - to your computer that uniquely identifies your browser and helps our website to run more smoothly. You can read about how Squarespace sites use cookies here - <https://support.squarespace.com/hc/en-us/articles/360001264507>.

A cookie does not collect personal information about you. A persistent cookie remains on your hard drive after you close your browser. Persistent cookies may be used by your browser on subsequent visits to the site. Persistent cookies can be removed by following your web browser's directions. A session cookie is temporary and disappears after you close your browser. You can reset your web browser to refuse all cookies or to indicate when a cookie is being sent. However, some features of our website may not function properly if the ability to accept cookies is disabled.

Our website uses Squarespace Analytics and Google Analytics to help understand use of Australia Re-made. This service collects the information sent by your browser as part of a web page request, including cookies and your IP address, and their use of it is governed by their Privacy Policies.

How We Use Your Information

We use the personal information you submit to operate, maintain, and provide to you the features and functionality of Australia Remade.

By providing us with your email address, you consent to our using the email address to send you Australia Remade-related notices, including any notices required by law, in lieu of communication by postal mail. We may use your email address to send you other messages, such as newsletters, or other information. If you do not want to receive such email messages, you may opt out by clicking on the unsubscribe link in the footer of any emails we send you or contact info@australiaremade.org.

Australia Remade reserves the right, but has no obligation, to monitor the user content you post on Australia Remade. We reserve the right to remove any such information or material for any reason or no reason, including without limitation if in our sole opinion such information or material violates, or may violate, any applicable law or to protect or defend our rights or property or those of any third party. We reserve the right to remove information upon the request of any third party.

How We Share Your Information

Personally Identifiable Information: we will not rent or sell your personally identifiable information to others. We may share your personally identifiable information with third parties (such as partner non-profit organisations) for the purpose of providing information and services related to Australia Remade to you. If we do this, such third parties' use of your information will be bound by this Privacy Policy. We may store personal information in locations outside our direct control (for instance, on servers or databases co-located with hosting providers).

Any personal information or content that you voluntarily disclose for posting, such as user content, becomes available to the public, as controlled by any applicable privacy or website customization settings. If you remove information that you posted to Australia Remade, copies may remain viewable in cached and archived pages, or if other users have copied or saved that information.

Except as otherwise described in this Privacy Policy, we will not disclose personal information to any third party unless required to do so by law or subpoena or if we believe that such action is necessary to (a) conform to the law, comply with legal process served on us or our affiliates, or investigate, prevent, or take action regarding suspected or actual illegal activities; (b) to enforce this policy, take precautions against liability, to investigate and defend ourselves against any third-party claims or allegations, to assist government enforcement agencies, or to protect the security or integrity of our site; and (c) to exercise or protect the rights, property, or personal safety of us, our users or others.

How We Protect Your Information

Australia Remade cares about the integrity and security of your personal information. We cannot, however, ensure or warrant the security of any information you transmit to us or guarantee that your information on the service may not be accessed, disclosed, altered, or destroyed by breach of any of our physical, technical, or managerial safeguards. Your privacy settings may also be affected by changes to the functionality of third-party providers, such as social networks. We are not responsible for the functionality or security measures of any third party.

Compromise of Personal Information

In the event that personal information is compromised as a result of a breach of security, we will promptly notify those persons whose personal information has been compromised, in accordance with the notification procedures set forth in this Privacy Policy, or as otherwise required by applicable law.

Your Choices About Your Information

You may, of course, decline to submit personally identifiable information to us, in which case we may not be able to provide certain services to you.

Children's Privacy

Protecting the privacy of young children is especially important. For that reason, Australia Remade does not knowingly collect or solicit personal information from anyone under the age of 13. In the
